An Airman can quickly cross a line between friendly conversation and harassing conduct by texting or posting images, which are in direct violation of the Air Force Discrimination/Harassment Policy. These violations can also include sexting (the sending of sexually explicit messages or images by cell phone), posting inappropriate pictures via Twitter/Facebook, and even as severe as posting racist comments via any form of social media.

We must not forget that professionalism does not stop when you leave the workplace and it also does not stop when we turn on our phone or computer. With just one click it is very easy for a text or post to be seen, read and interpreted as something completely different than what was originally intended. It is also easy for some Airmen to use this as an avenue of communication and say things they would never say or do in front of other individuals. Before they know it, with that one click of a button every emotional thought and feeling they've had goes viral and can never be taken back.

As military professionals we must remember that DOD instruction, AFI 1-1, 2.15, reminds us, "You are personally responsible for what you say and post on social networking services and any other medium. Regardless of the method of communication used, Air Force standards must be observed

at all times, both on and off-duty."

The Equal Opportunity (EO) office can be utilized to assist Airmen in processing and preventing climate issues involving the negative use of social media and technology. We can do this in many ways including training venues, such as commanders calls, core group discussions and any of our human relations education training.

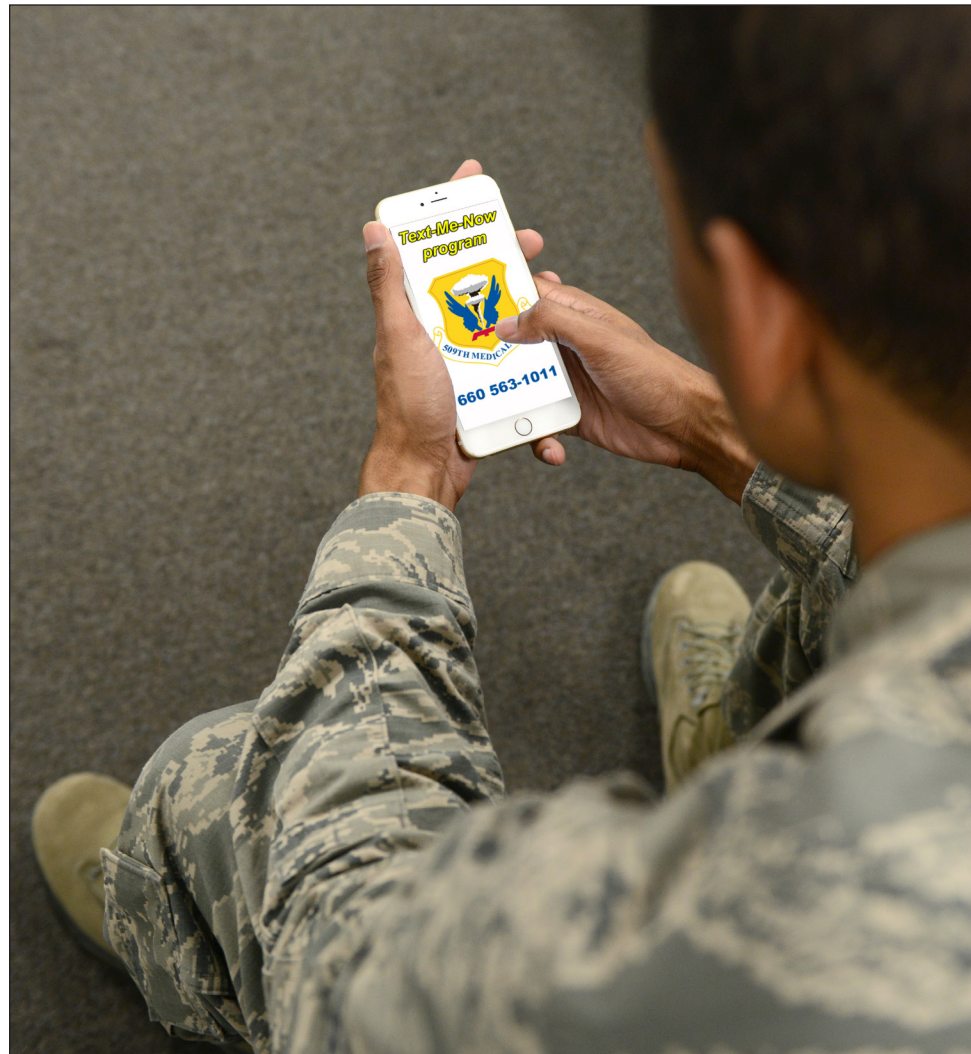

## Message delivered: Text-Me-Now program provides immediate response from Patient Advocates

The Patient Advocate program is already an extremely helpful resource for patients awaiting healthcare, and now with the addition of the Text-Me-Now program at Whiteman Air Force Base, Missouri, patients will receive almost immediate resolution for any issues that may arise while visiting the clinic.

The Text-Me-Now program, which originated at Altus Air Force Base, Oklahoma, and has made its way to Whiteman, makes the process more resourceful and immediate by allowing patients to text message an advocate at the clinic from their mobile device.

Traditionally, if a concern arises while a patient is at the clinic, they could ask to see the Patient Advocate by notifying a staff member. The staff would then seek out the advocate who could then come and consult with the patient to resolve the issue.

“If a patient wishes to see me, they can ask a staff member in the clinic, and they will be brought to my office or they can submit their concerns online through the Interactive Customer Evaluation (ICE),” said U.S. Air Force Capt. James Jordan, the 509th Medical Group (MDG) Patient Advocate. “There is no appointment necessary to see me, I’m available whenever a patient has an issue.”

While Jordan is the MDG advocate, there are advocates for each section of the clinic,

such as Family Health, Lab, Physical Therapy and so on. The program aims to help maximize the amount of patients assisted by minimizing the time it takes to seek out the advocate. It also increases the amount of patients that can be assisted at the same time.

“The program is beneficial because it gives the patient a direct and immediate line to myself or the alternate group advocate, Master Sgt. William Blackmon,” said Jordan. “They can be sitting in the exam room and text me and I can try to provide them with immediate resolution or address any of their concerns on-the-spot. They do not need to involve staff to seek me out.”

For example, if a patient is having an issue with the very staff member they would need to ask to find the advocate, the Text-Me-Now program allows the patient to avoid any interaction with staff other than the advocate. They can simply send a text message to the number with a brief description of the issue at hand.

The program is intended for use only while in the clinic for immediate issues and feedback. For other concerns, patients should access the ICE portal.

“The Text-Me-Now program is bringing patient care and alleviation of concerns into the modern ‘immediate resolution’ realm,” said Jordan.

# First car helps build solid foundation

Gripping the steering wheel and taking a deep breath, he inhaled the new car scent. After months of walking from place to place, the Airman finally had a vehicle to call his own.

On July 25, 2016, U.S. Air Force Airman Joerimer Collado, an individual protective equipment (IPE) specialist with the 509th Logistics Readiness Squadron (LRS) at Whiteman Air Force Base, Missouri, bought his first car with the help of his supervisor.

"I knew I would need a car when I arrived at my first base, but I was overwhelmed and I didn't know where to start looking," said Collado. "My supervisor helped me narrow down my options and he offered to take me out on the weekends to test drive some cars."

This is just one example of how the IPE element has helped their Airmen transitioning into their new Air Force lifestyle. Air Force Global Strike Command (AFGSC) announced 2017 as the year of the family, which focuses on investing in Airmen to help them overcome challenges and help sustain a resilient Air Force community.

"We are in a profession of arms; this occupation requires a dedication that other occupations don't," said U.S. Air Force Gen. Robin Rand, the AFGSC commander. "If we are going to do the job right, if we are going to take care of each other properly, we have to build on a solid foundation."

The IPE team is made up of Airmen from different countries, such as Peru, Philippines, and

Central Africa. It is the camaraderie within the element that has helped lay down this foundation and boost morale.

"Shelf life, gas mask testing, inventory, and weapons cleaning are tasks that should be boring, but they aren't because I am able to talk to other people while doing it," said U.S. Air Force Airman Aleandro Pust Cuniberti, a fellow IPE specialist with the 509th LRS.

Pust Cuniberti, also known as PC, was born in Lima, Peru, before moving to Los Angeles at four years old. At the age of 20 he decided to join the military for a stable job, travel and to continue his education.

He joined the IPE team just one month after Collado in July 2016. However, PC did not have a driver's license when he enlisted in the Air Force. This gave Collado the opportunity to pay it forward and help out his wingman.

"I really appreciate Collado helping me out by giving me tips and inviting me to practice driving after work once I got my permit," said PC. "Also, I am thankful for everyone being patient with me through the process and not making me hurry."

On Oct. 6, 2016, PC was able to obtain his driver's license.

"Both Airmen are hard workers and dedicated to each individual task that is assigned to them, and they have helped develop great camaraderie within the shop," said Staff Sgt. Rey Jee Quilla, an IPE specialist with the 509th LRS and Collado and PC's supervisor. "It is important to invest in your Airmen and help them out with things they need outside of work because the challenges they face in their personal lives can carry over to how they perform the mission."

# Time to file income taxes!

It's that time of the year again - time to file income taxes! To help members of Team Whiteman efficiently and effectively get their taxes filed, the base tax office will operate Monday - Friday from 8 a.m. - 4 p.m.

Starting on Feb. 1, 2017, the tax office will begin processing tax returns for individuals who meet the criteria listed below. We can assist in the preparation of federal and state tax returns as well as e-file those returns for you.

**Criteria:** Volunteers will help prepare your state and federal tax returns so long as your gross income is under \$150,000; you have no substantial rental properties/business income; and there is no history of bankruptcies, foreclosures, or other type of cancellation of debt as these issues exceed the expertise of this volunteer program. If you have any questions, call our appointment line for more details.

**Who:** Service is available to all Active Duty, Guard and Reserve personnel, as well as Department of Defense civilian employees, dependents, and retirees.

**Where:** Professional Development Center

(PDC), Building 515, Room 208. Also new this year – we will have a satellite office at the University of Central Missouri (UCM) Office of Military and Veteran Services, Elliott Student Union 117.

**Phone Number:** To make an appointment, call Whiteman Legal Office at 660-687-6809, or UCM Veteran's Center at 660-543-8776.

**Hours for appointments:** Typically, appointments will be Monday – Thursday, 8 -11 a.m. and 1 - 4 p.m. at the PDC. Call UCM for hours of operation. Exceptions can be made given the circumstances, call with any questions.

**Walk-In Hours:** Friday, 8 – 11 a.m. and 1- 4 p.m. (1040EZ filers only).

**What is needed for tax returns:**

- Copy of all tax paperwork (W-2s)
- Social Security cards for all individuals on tax return
- Bank account number and routing number for tax return
- Copy of last year's refunds/payments tax return, if available

# Tax delinquency and the military

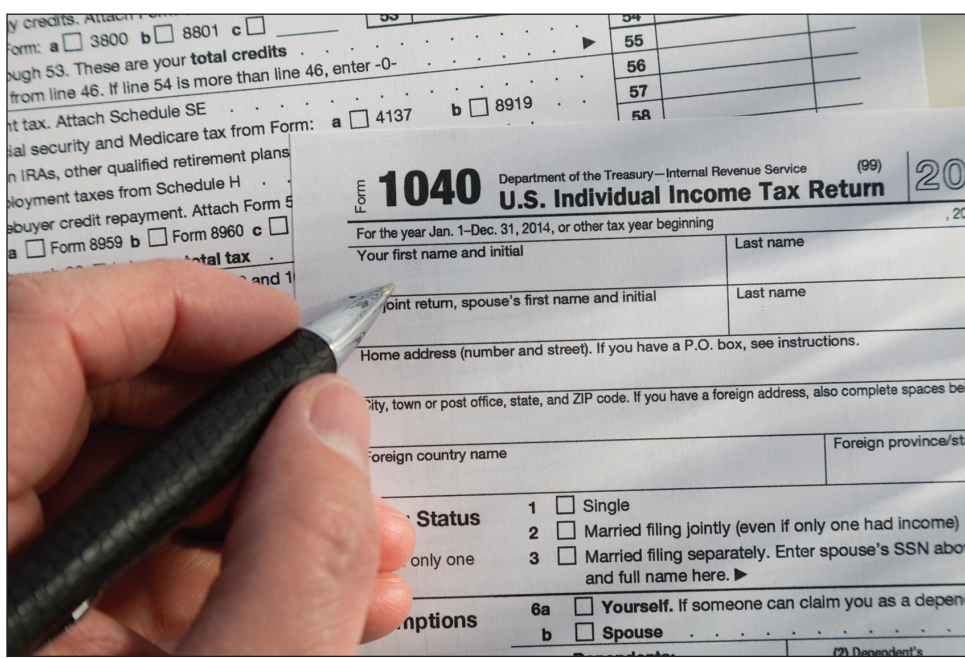
The 2016 tax season is upon us! As of Jan. 20, 2017, W-2 forms are available for all military personnel. This year's filing deadline will be April 18, 2017. Please be aware that although you may file your taxes properly and timely, you may still receive a delinquent notice from the Missouri Department of Revenue (MDR), even if you have another "home state" for tax purposes.

Last year, the Whiteman legal office received several reports of military members receiving tax delinquency notices from MDR. Missouri began sending tax notices to Whiteman members whose home of record is not Missouri. If you receive a notice like this from the MDR be aware: If your home of record is not Missouri, then you are protected by the Servicemembers Civil Relief Act (SCRA).

The SCRA prevents military personnel from being taxed on their military income by any state other than their home of record. Under the SCRA, the laws of the state listed as your home of record determines whether you are required to pay state income tax on your military pay. For example, if you are stationed here at Whiteman and your home of record is Mississippi, then you follow the tax rules of Mississippi and file through that state ... not Missouri.

We advise all members who are not legal residents of Missouri, but receive a Missouri tax delinquency notice on their military pay, go to the Military No Return Required page at <https://sa.dor.mo.gov/nri> to be exempted from filing a Missouri income tax return. As an alternative you can send a rebuttal to the Missouri Department of Revenue. Missouri does not require you to submit any documentation with your rebuttal letter, but it is helpful to include a copy of your military orders and your most recent state tax return. MDR is aware of this issue and is working hard to ensure a more speedy process to resolve SCRA cases.

It is important that you respond to the delinquency notice as soon as possible, but in the meantime, do not panic. If you have received a Missouri income tax delinquency notice, the base legal office can assist you in filing your rebuttal. Walk-in legal assistance hours are Tues-

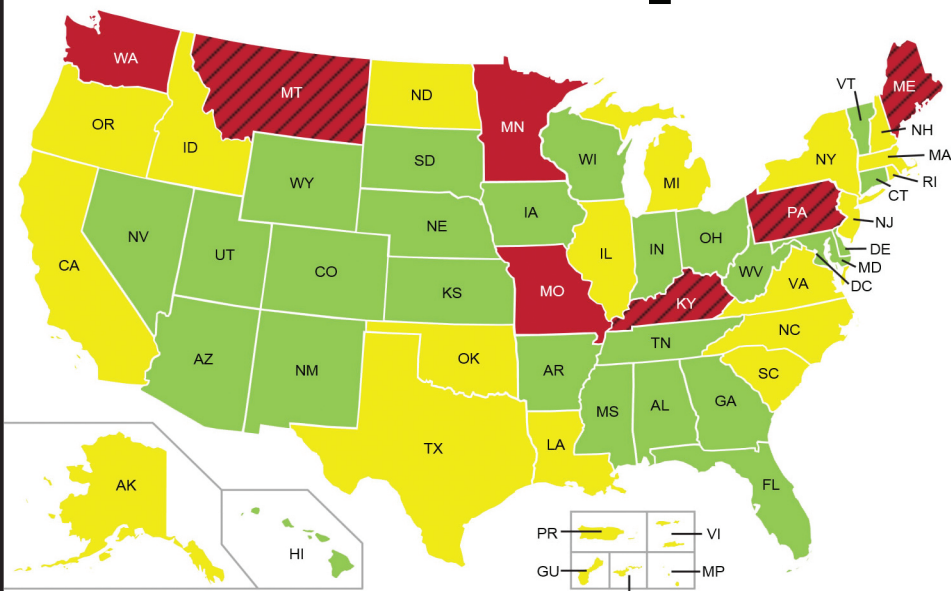

A special note for military members with an official state of residence of Missouri and who are stationed in Missouri: On June 28, 2016, by Missouri Senate Bill 814, the law was changed to allow for Missouri military members, while stationed in Missouri, to be exempt from paying state income tax.
